So suffering through the pain now could mean bigger gains when you do call it quits.

Protect Yourself

Protect yourself from too much debt. Tough economic times have a way of focusing attention on simple ideas that can be easily overlooked in good times. Consider these four steps to ward off troubles caused by falling too deep into debt.

First – Prepare for the worst-case scenario. Example – Take out a mortgage you can afford to pay on only one income, even if both spouses work.

Second – Keep an emergency fund – at least six months' worth of expenses. With lenders pulling back equity lines, it's important to build up your emergency fund even if you have to temporarily decrease retirement plan contributions.

Third – Lower your credit card interest rates now. Ask the card company for a better deal or take advantage of a 0% balance-transfer offer.

Fourth – Aim to pay off your mortgage before retiring. Ending that debt can give you more flexibility, especially if your investments are down and your other expenses have increased.

Volunteer for a longer healthier life. It sounds like Karma, but it could be just plain old common sense.

When you volunteer a couple of hours a week to help others, you may be adding years and vitality to your own life.

People who give of their time and talents report higher levels of happiness and satisfaction, as well as a greater sense of purpose and control. Other benefits of volunteering can include reduced stress, lower blood pressure, less isolation, and fewer health problems later in life.

Illegal Aliens and Private Employment

Notice to all South Carolina Employers regarding Illegal Aliens and Private Employment. Governor Mark Sanford signed a new law on June 4, 2008, the "South Carolina Illegal Immigration and Reform Act". Form I-9 covers most of the requirements, but if you do not get a copy of a valid driver's license, please either verify the employees' work authorization program administered by the U.S. Department of Homeland Security or do this:

Verification Requirements

In addition to completing and maintaining the federal employment eligibility verification form, more commonly known as the Form I-9, all South Carolina employers must within five days after employing a new employee:

- 1. Verify the employee's work authorization through the E-Verify federal work authorization program administered by the U.S. Department of Homeland Security; or
- 2. Verify that the employee
 - (a) possesses a valid South Carolina driver's license or identification card issued by the South Carolina Department of Motor Vehicles;(b) is eligible to obtain a South Carolina driver's license or
 - (b) is eligible to obtain a South Carolina driver's license or identification card; or
 - (c) possesses a valid driver's license or identification card from another state whose qualification requirements are as strict as those of the state of South Carolina.

The South Carolina Department of Motor Vehicles has determined that drivers' licenses or identification cards issued by the following states are acceptable: AK, AZ, CT, FL, GA, ID, IN, ME (credentials issued after 11/15/08), MA, MI, NH, NJ, PA, RI, TX and VA.
